Attention Lake 'n Golf Boat Owners

April 14, 2021 at 1:00pm I would like to meet with boat owners to hand out new rules for the use of the storage lot and the dock and go over slip lists. ANY outburst from anyone and you will be asked to leave. Be civil, respect others.

NO ONE holding a slip, upon leaving Lake 'N Golf, may NOT just tell someone they can have your slip. Slips have to be given by the Harbor Master. NO exceptions. Waiting list: no one will be placed on the waiting list without owning a boat, boat owners only on the list.

As of May 31, 2021, ALL boat trailers must be licensed by state law, no exceptions. [per Winter Haven City Code Enforcement Officer]. All trailers must have your name and slip number attached to the front of the trailer.

I will be matching boats, slips and trailers. Any trailer not licensed, tagged or proof of resident must be removed now. Reminder: only boat trailers are to be stored in the lot. Find another place to store your trailer. Your trailer will be tagged for 30 days then removed from the lot.

If you leave for the summer let me know so a temporary can be assigned to your slip. Before returning give Harbor Master two weeks notice so temporary can move from your slip.

Any boat owners not agreeable to the above, please find another free spot to house your boat and trailer. All boats must be placed in the water for more than 1 hour and returned to storage lot for free storage. Also, boats are to be used and not just docked all year taking up a spot. I'm not writing this to be mean or anything or cause hard feelings. I have put a lot of time in this so Lake 'N Golf will not lose storage area with the city.
